Summary of Supplemental Response to FOIA Request EPA-R4-2021-005067, following meetings held with requestor on January 5 and 11, 2022.

### 1. The basis for EPA's decision to issue the May 13, 2021 CAA Section 303 Order.

The basis for EPA's decision to issue the May 13, 2021 Order is contained in the Administrative Record supporting that decision, an index of which is included with this response. Many of the documents are either already publicly available or are more administrative in nature. Therefore, with this response, EPA is providing you with the documents that are not already publicly available, and that Region 4 believes would be of most interest to you. Those documents are highlighted in the index included with this response.

#### 2. The basis for EPA's decision to file the Complaint on July 12, 2021.

The basis for EPA's decision to file the Complaint is contained within the Complaint itself, and other publicly available records referenced in the Complaint (for example, New Indy's fence line monitoring results). To the extent other documents leading up to the decision to file the Complaint exist, they would be covered by FOIA exemption 5 as deliberative process, attorney work product and/or attorney client communication, as well as FOIA exemption 7(A) as information compiled for law enforcement purposes.

### 3. The basis for the number and location of fence line monitors required by the 303 Order.
